Sir,

A referene has been received from Regional P. F. Commissioner, Rajasthan vide his letter no. 1(90)/Pay fixation/Adm.I/1823, dated 3.9.2009 seeking clarification with regard to fixation of pay to be made in respect of those officials who were given the benefits of upgradation under Time Bound Promotion Scheme upto 31.3.2004 and were promoted as Section Supervisor after 1.4.2004 whether they will be allowed to pay scale of Rs. 5500-9000 with effect from 1.4.2004 and the fixation will be made under FR 22 (1)(a)(2) or otherwise and whether this order dated 20.5.2009 is in supersession of previous order dated 15.1.2009.

2. In this connection it is clarified that on implementation of pay scale of Rs. 5500-9000 (pre-revised) to the officials who were promoted under Time Bound Promotion Scheme as non-functional Head Clerks upto 31.3.2004, the fixation benefits to such officials have been allowed with effect from 1.4.2004 and their pay will be fixed under FR 22 (1) (a) (1) and after getting the promotion to the post of Section Supervisor from Sr. Social Security Assistant (TBP) on or after 1.4.2004 they are not entitled for the second time to get the benefits under FR 22 (1)(a) (1) in the light of earlier instructions issued vide Head office letter no. HRM.III/3(9)87/TBP/Vol.II, dated 29.6.2000. You are therefore requested to take necessary action accordingly.
